- Estimated timing not being met or changes in expected litter dates
- Unavailability of preferred sex, color, or specific puppy
- Buyer's decision to withdraw, purchase from another breeder, or decline a puppy
- Any other reason whatsoever

WAITLIST AND ESTIMATED TIMING ACKNOWLEDGMENT

By signing this Agreement and paying the deposit, Buyer acknowledges and understands that:

1. This deposit places Buyer on Exact Classic Bulldogs' waiting list for a future litter/puppy. Positions are managed at Seller's discretion.

2. EXPECTED TIMING FOR RECEIVING A PUPPY IS AN ESTIMATE ONLY AND IS NOT GUARANTEED.

Actual availability depends on successful breeding, health of dam/sire/puppies, litter size, and factors beyond Seller's control.

3. Seller does NOT guarantee a puppy from any specific litter, a particular timeframe, a specific puppy, or exact match to all preferences.

4. When a suitable puppy becomes available, Buyer will be contacted and may accept or decline. Declining or failing to respond does not entitle Buyer to a refund.

5. Buyer agrees to maintain current contact information and respond to Seller communications within a reasonable time (typically 24–48 business hours) when notified of an available puppy.

Buyer assumes full and sole responsibility for any and all decisions regarding future vaccinations, deworming, preventive care, or health management after taking possession of the puppy. Seller makes no warranties regarding vaccination status and shall not be held liable for any health outcomes Buyer or Buyer's veterinarian may attribute to the lack of vaccination or to Buyer's subsequent care decisions.

1. **JURISDICTION & VENUE:** This Agreement is governed by the laws of the State of Indiana. Any disputes shall be resolved in the courts of Allen County, Indiana. Buyer agrees to this venue.
2. **SELLER'S RIGHT OF REFUSAL:** Seller reserves the right to refuse sale to any buyer for any reason and may return the deposit (minus any processing fees) if Seller determines the placement is not suitable.
3. **SEPARATE PURCHASE AGREEMENT:** This document is a Waitlist Deposit Agreement only. A separate Purchase/Sales Agreement will be executed at the time of final payment and puppy pickup/delivery. That agreement will include health guarantee details (if any), delivery/pickup terms, microchip information, and other standard terms.
4. **BREED CHARACTERISTICS:** Buyer acknowledges they have researched English Bulldogs and understand the breed's characteristics, including potential brachycephalic (flat-faced) health considerations. Buyer accepts responsibility for the puppy's ongoing care.
5. **ENTIRE AGREEMENT:** This document, together with the future Purchase Agreement, constitutes the full understanding between the parties. No verbal agreements modify these terms.
